Candidates are advised to download their respective Admit Cards from <https://exams.nta.ac.in/HCG/> by using their respective Application Number and Date of Birth. Candidates are also advised to read the Instructions contained therein carefully and to note the following:

- The Admit Cards is issued **provisionally to the candidates**, subject to fulfillment of the eligibility condition.
- **Kindly note that for each post the Roll Number and Admit Card will be different.** Therefore, candidates who have applied for more than one post, are required to download the Admit Card separately for each post.
- Admit Card will **not be sent by post.**
- Issue of Admit Card, however, **will not necessarily mean acceptance of eligibility** which shall be further **scrutinized at subsequent stages** of the recruitment process.
- Candidates are advised to preserve a copy of their Admit Card and keep it in good condition for further reference.
